

Release and Waiver of Liability

Winston-Salem Industries for the Blind, Inc. d/b/a IFB Solutions, a North Carolina nonprofit corporation, including its officers, directors, employees, agents, volunteers, licensees, successors and assigns (collectively, the “**Company**”) is organizing an event, IFB Solutions FootGolf Tournament (“**Event**”). I desire to participate in this Event and its related activities. By registering for this Event, I acknowledge that I have read, understand, and agree to abide by all of the Event rules and requirements.

I acknowledge that: I am voluntarily participating in this Event; that I am under no obligation to participate in the Event, nor am I under any obligation to continue to participate in the Event once it has begun. Likewise, my participation in this Event is a revocable license that the Company may withdraw. I am aware that there are risks, including, but not limited to, risk of serious bodily, personal, or property injury, associated with my participation in the Event and its related activities. These risks may increase based on various factors such as my health, the actions of other participants, the weather, traffic, and/or Event locale. I hereby expressly and specifically assume such risks, including any and all risk of injury or harm that I may incur as a result of my participation.

I understand that in the course of my participation in the Event, I may interact with volunteers performing services for the Company. I understand that under North Carolina law, such volunteers may owe to me a limited duty of care with regard to the performance of such services.

I hereby give consent and authority to the Company to obtain medical treatment on my behalf if I become ill, am injured, or require medical attention during my participation in the Event. I understand and agree that I am solely responsible for all costs related to such medical treatment, medical transportation, and/or evacuation. I hereby release, forever discharge, and hold harmless Company from any claim whatsoever in connection with such treatment or other medical services.

I hereby fully and forever release the Company from, and expressly waive, any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, that may arise from my participation in or associated with the Event. I covenant not to bring any such claim against the Company, and fully and forever release and discharge Company from liability under such claims. I UNDERSTAND THAT THIS RELEASE DISCHARGES THE COMPANY FROM ANY LIABILITY OF CLAIM THAT I MAY HAVE AGAINST THE COMPANY WITH RESPECT TO ANY BODILY INJURY, PERSONAL INJURY, DEATH, PROPERTY DAMAGE, OR PROPERTY LOSS THAT MAY RESULT FROM MY PARTICIPATION IN THE EVENT.

BY SIGNING, I REPRESENT AND WARRANT THAT I HAVE READ AND UNDERSTAND THE PROVISIONS OF THIS RELEASE AND WAIVER OF LIABILITY, THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE COMPANY, AND AGREE TO ABIDE BY AND BE BOUND BY THESE PROVISIONS.
